Introduction

The Groups assigned to each man refer to their ages as allocated in Lord DERBY's Scheme. Those who attested their willingness to serve were given a grey coloured arm band upon which there was a red crown.

The Group numbers given to the men may be explained simply.

Having been appointed Director General of Recruiting Lord Derby brought forward a Scheme whereby men aged 18 to 40 could continue to enlist voluntarily or attest with an obligation to join if called up later on. The War Office notified the public that voluntary enlistment would cease and that the last day of registration would be 15 December 1915.

The men who attested under the Derby Scheme were classified into married and single status and into 23 groups according to their age. The single men would be called up before those who were married.

In using this index it is strongly recommended that referral should be made to the original record so that the full significance of the entry can be judged and also as a check against mistakes made by the indexer. Although the records are typewritten, the faintness of some characters renders the differentiation between some (H & N for instance) as uncertain. Occasionally there is a handwritten addition.

Thanks are due to the staff at Lambeth Archives, in particular Len Reilly for his patience, help and advice.

Foreword

Military Tribunals were set up by local councils for men wishing to appeal for exemption against military service consequent upon conscription. In 1914 at the start of war, enlistment had been voluntary but as numbers dwindled the Derby Scheme was introduced in Autumn 1915 by which men who registered would be called for service when required. Numbers dwindled again and the scheme was abandoned. Liability for compulsory service came with the Military Service Act from 2nd March 1916, extending liability in May 1916 and further with an upper age limit of 51 years in 1918.

It will be seen that exemption was claimed on domestic or business grounds and conscientious objectors were given non-combatant roles.

The first meeting of the Local Tribunal for the Metropolitan Borough of Lambeth was held at the Town Hall, Brixton Hill, on Thursday 30 December 1915 at five o'clock in the evening. Those present were:

His Worship the Mayor (Alderman C.H. GIBBS J.P.), Councillor F BRIANT J.P., Councillor George BRITTAIN J.P., Alderman F BUDGE, Alderman W.J. DAVEY, J.C. HATCH Esq., J.P., Alderman G. HINDS, N.W. HUBBARD Esq., J.P., T Owen JACOBSON Esq., J.P., C.F. PARTINGTON Esq., J.P., Alderman J.F. TOWNESEND. The War Office Representative was also present. Captain W Burgh TURNER had been appointed by the War Office.

As the names of those members of the Tribunal changed through the course of the meetings, they have not been recorded for the purpose of this index.

The first case recorded in the first volume of these records was for Charles H.A. KEMPTON in the employ of Charles Henry KEMPTON of 45 South Lambeth Road, Vauxhall, S.W., Manager for the Public Lamp Contractors. He was alleged to be in a "reserved occupation" but not actually "starred" (employed in war related work) - the observation of the Recruiting Officer was that his claim be not assented to. The man was not present and the Tribunal concurred with the R.O.'s observation.

There were claims for deferment by employers and attested men. Meetings were held often in three sessions in each of the days that the Tribunal met.

A reader finding a reference in which they are interested must refer to the appropriate volume in order to gain a full perspective of the record. Amongst entries of a more general interest are JA SHARWOOD pickle manufacturer claiming for his employees; EC DUFAUR age 30 Purveyor of Horse Flesh - his claim was not allowed; the firm of David GREIG had a large claim for deferment. There were many claims from men connected with theatres in Lambeth, for instance Fred KARNO claimed for the deferment of FH SANDY a General Manager. Page 12

A Communication date 16 May 1916 was received from the Clerk to the Bethnal Green Tribunal enclosing the following Resolutions which had been unanimously adopted by that Tribunal at the Meeting on 15 May 1916

Page 13

(1)

That the Bethnal Green Tribunal views with deep concern the fact that while our own men are fighting for their King and Country male allied and enemy aliens of military age are allowed materially to strengthen their industrial position without any sacrifice.

(2)

That it is the deliberate opinion of this Tribunal that this is now, and will be after the war, a serious menace to the commercial interests of the British subjects within this Borough, who, having answered their Country's call, return the {sic} find the alien firmly established in all branches of the trades which were theirs. (3)

That this Tribunal is of opinion, on the grounds of justice, that it should be equal sacrifice for all, who, domiciled in this country, enjoy its liberties and protection.

This this {sic} Tribunal hopes, in view of these facts that the Government will immediately take the necessary steps compulsorily to remedy this obvious injustice.

(5)

That a copy of the foregoing resolutions is transmitted to the Prime Minister, Lord Kitchener, Mr Bonar Law MP, the President of the Local Government Board, Mr Arthur Henderson MP, the Members of Parliament for the Borough, the London Local Tribunals, and the Bethnal Green Borough Council. The hope is expressed that these Resolutions will commend themselves to the Local Tribunal and that it will take such steps as it may deem expedient to secure that effect shall be given to the representations contained therein. It was resolved that a communication be addressed to the Clerk of the Bethnal Green Local Tribunal intimating that the Lambeth Local Tribunal concurs in the suggestions contained in the above resolutions.

Page 14 Case 1905 AP SA(xxx)E 1916 22 May
At meeting Friday last applicant stated that the Directors of Messrs PAGE &
OVERTON's Brewery, Croydon, would not consent to his house "The
Perseverance" Robsart Street, being left in his wife's charge if he were taken for
Military Service.

The Hon. Clerk has now to report that a representative of the Brewery called upon him this (Monday) morning and stated that this matter has been considered by the Directors of the Brewery and that, having regard to the estent {sic} and character of the business done at this house, to the fact that the wife is only 22 years of age and did not enjoy good health, and to the many orders to which the trade are now subject, this was a case in which their practice of permitting the wife of a lessee to carry on the business, must be departed from.

Page 28 Case 1947TE PRICE 1916 May 26

"This Case was heard by the Tribunal at its Meeting on 17 May, when the Tribunal decided not to assent to the Claim. It was afterwards found, however, that through a clerical oversight the applicants had not been given the usual official notice of hearing, consequently they were not prepared with certain particulars which might possibly lead to the Tribunal coming to a different decision. In these circumstances, the Clerk to the Tribunal has arranged for the case to be re-heard."

Page 64 1916 Jun 7

A letter date 27 May 1916 was received from the Hon. Secretary of the British Undertakers' Association (London Centre) with regard to the exemption of Undertakers from Military Service.

The Clerk to the Lambeth Tribunal reported that he had received from the Labour Exchange a list of the trades in which the demand for really skilled men to take up munitions work is urgent.

Page 68 Case C2/254 CF CLEMENTS 1916 Jun 9
Reported in the Lambeth Minutes for June 9th at the meeting of the Lambeth Tribunal (held at the Town Hall, Brixton Hill) it was stated that the Appeal Tribunal of County of London "The man be exempted from Combatant Service only, subject to the proviso that if he undertakes work which in the opinion of the Tribunal is of national importance, and under conditions approved by the Tribunal, he shall be exempted from non-Combatant Service so long as he continues to carry out such work under such conditions.

"The Tribunal were of opinion that the present occupation of the respondent as a general farm hand, employed at Stoke Park Farm, Slough, Bucks, fulfilled that condition, and was approved of."

Reported in the Lambeth Minutes for June 9th at the meeting of the Lambeth Tribunal (held at the Town Hall, Brixton Hill) it was stated that the Appeal Tribunal of County of London "The man be exempted from Combatant Service only, subject to the proviso that if he undertakes work which in the opinion of the Tribunal is of national importance, and under conditions approved by the Tribunal, he shall be exempted from non-Combatant Service so long as he continues to carry out such work under such conditions.

"The Tribunal were of opinion that the present occupation of the respondent as Inspector of Material in the manufacture of aeroplanes at Messrs. Hanley Page Ltd, 110 Cricklewood Lane, NW., fulfilled the condition and was approved of."

Page 73 Stepney Local Tribunal letter of 6 Jun 1916 Jun 9 They are adopting the following resolution with regard to Aliens of Military Age serving in the Forces: "In the opinion of this Tribunal, if the Government is not prepared to say that aliens domiciled in this country for years who have shared its privileges and liberties in days of prosperity, should equally, with its own citizens, be called upon to defend it in its hour of danger, it should at least give

those of them who desire, of their own free will to serve it, an opportunity of doing so, by the formation of a foreign legion or some properly safeguarded permission to enlist in certain British regiments." It was resolved that the Lambeth Tribunal concur in this resolution.

Page 103 O'DWYER FW 1916 Jun 19 Appeal Tribunal of Co of London

This man exempted from the provisions of the Military Service Act 1916 on the ground that serious hardship would ensue if he were called up for army service owing to his exceptional domestic position, but such exemption is conditional upon his undertaking work of national importance. The Tribunal is satisfied that his present employment as Clerk in the Central Office, Royal Ordnance Factories, Woolwich Arsenal, fulfils this conditional.

Page 106 PITTS FAG 1916 Jun 19

The Tribunal will recall that this case was adjourned in order that it might be ascertained whether the Bentinck Motor Supply Co., of whom Mr PITTS bought his cab, would make any arrangements as to the taking over and running of the cab on his behalf should he have to join the Forces. A letter dated 13th Jun 1916 has now been received from the Company regretting that it is unable to do this as it has no facilities in London for such class of work. In other instances where Cab Hirers have been called up the Hirer has either made an arrangement with a friend (with the Company's consent) to take over the Agreement – it presumes for a consideration – or, with the consent of the Hirer, the Company has taken back the Cab and cancelled the Agreement.

Page 123 CORBET W 1916 Jun 23

The Appeal Tribunal of County of London "The man be exempted from Combatant Service only, subject to the proviso that if he undertakes work which in the opinion of the Tribunal is of national importance, and under conditions approved by the Tribunal, he shall be exempted from non-Combatant Service so long as he continues to carry out such work under such conditions. "The Tribunal were of opinion that the present occupation of farm work under Mr WW BERRY, Gushmere Court, near Faversham as being work entitling him to exemption from non-combatant service."

Page 138 COLE GM 1916 Jun 26

Letter dated 24 June that not being a Mechanic or Engineer in the recognised sense, he can only obtain labourer's work in Munitions. He has, however, been offered, and accepted, Government work at HARRISONS (Government Printers), 95% of which firm's work, he states, being carried out for the Government. He asks, therefore, that he may be allowed to continue in the

printing trade with Messrs HARRISONS, rather than take up Munitions work as a labourer. It was resolved that the request be not acceded to.

Pages 156/7 & 165 Special Proviso re: application for variation of Certificate already granted on conscientious grounds.

Exemption from Combatant Service only, subject to the proviso that if, within 21 days the applicant undertakes work which, not being under Military control is nevertheless useful for the prosecution of the war under the direction of the Committee on work of National Importance, and under conditions approved by the Tribunal, he shall be exempted from non-combatant service so long as he continues to carry out such work under such conditions, the work proposed to be reported to the Tribunal for approval. Power is reserved to the Tribunal to extend the period of 21 days, or to vary this order if the Claimant establishes to their satisfaction that he has done his best but has failed to comply with the condition.

Page 168 COLE GM 1916 Jul 3

Letter from Messrs Jas TRUSCOTT & Son Ltd, Printers of the Parliamentary Debates in the House of Commons, enclosing a letter from the Controller of H.M. Stationery Office, suggesting that the printing of these debates is of national importance and that it is essential that Messrs TRUSCOTT should endeavour to secure the service of another man in place of one of their men who is leaving to take up munition work, and recommending that Mr COLE, who has been conditionally exempted from Military Service by the local Tribunal, should be granted total exemption on the condition that he accepts for the during {sic} of the War the post of Linotype Engineer in connection with the work. Granted – in connection with the Official Reports of the Parliamentary Debates.

Page 289 GRUTZMACHER RR 1916 Aug 1

It might be noted that this man, Robert Richard, a 26 year old hair dresser and wig maker, is the son of a German hairdresser and might be considered as falling in the class of alien as outlined in the letter from the Stepney Local Authority Tribunal referred to on **Page 73** (as above).

Page 301 Re: Comprehensive Claim by Peter MUMFORD and Sons for their employees

Mr FW HEADLEY, Foreman, in a letter to the Lambeth Tribunal, stated that not only are the men obliged to work overtime almost every day in order to fulfil Army orders, but owing to the number of men employed being reduced because of the call of the Army, those remaining have to work more strenuously than at ordinary times. None of the men are averse to doing whatever they can in the interests of the country but they feel that the effect of joining either of the Forces mentioned would make it impossible for them to carry out their ordinary duties. A request is therefore made to the Tribunal that the condition of exemption shall not apply in the case of the following men: FW HEADLEY, FG ELMER, T

LAWRENCE, J POULTNEY, H PAGE-CHESTNEY, J RUSSELL, C WILDER & J BRESNETT. It was resolved that four of the eight above mentioned men be allowed to be excused from joining the V.T.C.
